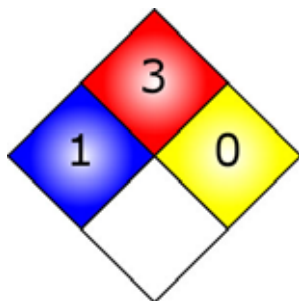

## 4. FIRST AID MEASURES

### General advice

## 6. ACCIDENTAL RELEASE MEASURES

### Personal precautions, protective equipment and emergency procedures:

Do not inhale vapors, mist or gas. Ensure adequate ventilation. Remove all sources of ignition. Evacuate personnel to safe areas. Beware of vapors accumulating to form explosive concentrations. Vapors can accumulate in low areas.

### Environmental precautions:

Stop leak. Contain spill if possible and safe to do so. Prevent product from entering drains.

Long-term exposure (2 years) to Isopropyl Alcohol via inhalation at concentrations up to 5000 ppm caused no exposure related increases in tumors in animals.
